## NOTIFICATION FOR ADMISSION INTO BAMS/BUMS/BHMS/BNYS COURSES UNDER COMPETENT AUTHORITY QUOTA FOR 2024-25 IN THE STATE OF TELANGANA AFFILIATED TO KNRUHS, WARANGAL

Applications online are invited from the candidates who have qualified in National Eligibility-cum- Entrance Test (NEET) UG – 2024 and who have fulfilled the following criteria for admission into Undergraduate AYUSH Courses i.e., BAMS, BHMS, BUMS & BNYS for the academic year 2024-25 under Competent Authority Quota in Government and Private AYUSH colleges affiliated to KNRUHS, Warangal in the State of Telangana.

Notification is issued for online registration to determine State Merit position for web based counseling and admission into Competent Authority Quota seats only i.e., after deducting 15% of intake of seats contributed to All India Quota from the seats in Government AYUSH colleges and Private AYUSH Colleges. Total number of seats available under Competent Authority Quota in all categories along with seat- matrix for the academic year 2024-25 will be notified on KNRUHS website before exercising web options for counseling. Tuition fee will be as notified by the Government of Telangana.

### Minimum Qualifying Scores in NEET- UG- 2024

Candidates should have secured the following cutoff score or above in NEET- UG-2024.

Provisional final merit position of the applied candidates will be prepared based on the NEET UG - 2024 Rank and other eligibility criteria notified hereunder after verification of scanned original certificates. Final Verification of original certificates will also be conducted at the time of admission at allotted college by Admission Committee.

### I. ELIGIBILITY:

**A.** Candidates, who have qualified in NEET- UG -2024 by securing marks of cutoff score or above have to apply for determining the State Merit position for Competent Authority quota seats subject to the conditions specified in admission Regulations/Prospectus.

### B. Eligibility as Local Candidate

### (as per G.O.Ms.No. 138 HM&FW(C1) Dept. Dated: 04-10-2024):

**Nationality & Domicile**: A candidate for admission into Undergraduate AYUSH courses under Competent Authority Quota in Telangana should be Indian National/Person of Indian Origin (PIO)/Overseas Citizens of India (OCI) card holder and shall fulfill the following conditions

i) The candidate should have studied in the Educational Institutions in the state of Telangana for a period of not less than four (4) consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in the relevant qualifying examination.

or

- ii) Where during; the whole or any part of the four (4) consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared for the relevant qualifying examination, he has not studied in Educational Institutions, he should have resided in the state of Telangana for a period of not less than four years immediately preceding the date of commencement of the relevant qualifying examination, in which he appeared or as the case may be first appeared.
- iii) Further, in case the candidate has not studied in any educational institution and has resided in the state of Telangana as stated at (ii) above, to be eligible for admission into Undergraduate AYUSH courses under Competent Authority Quota, the candidate should have appeared for the relevant qualifying examination in the State of Telangana.

NOTE: Domiciles of other states are not eligible for Competent Authority Quota seats

### in the state of Telangana.

### C. Educational Qualification:

In accordance with NCH/NCISM Regulations

Candidates seeking admission into B.A.M.S./B.H.M.S/B.N.Y.S. Courses should have passed Intermediate Examination (10 + 2 pattern) or its equivalent examination with Physics and Chemistry, Biology (Botany, Zoology)/ and English.

- OC candidates should obtain not less than 50% Marks in the science subjects.
- ii. BC/SC/ST candidates should obtain not less than 40% Marks in the science subjects.
- iii. OC PWD candidates should obtain not less than 45%Marks in the science subjects.
- iv. Candidates claiming reservation under EWS Category also should obtain50% marks in Science subjects.

## D. ELIGIBILITY FOR ADMISSION INTO BUMS COURSE AS PER REGULATIONS OF NATIONAL COMMISSION FOR INDIAN SYSTEM OF MEDICINE:

**Admissions to Kamil-E-TIB-Wa-Jarahat course:** A candidate seeking admission to main Kamil-E-Tib-Wa-Jarahat (Bachelor of Unani Medicine and Surgery – B.U.M.S.) Course must have passed.

- i. OC candidates should obtain not less than 50% Marks in the science subjects.
- ii. BC/SC/ST candidates should obtain not less than 40% Marks in the science subjects.
- iii. OC PWD candidates should obtain not less than 45%Marks in the science subjects.
- iv. Candidates claiming reservation under EWS Category also should obtain50% marks in Science subjects.
- v. Candidate shall have passed Urdu or Arabic or Persian language as one of the subjects in the 10<sup>th</sup> Standard or in 12th Standard.
- vi. Candidate who is not covered under clause (b) shall have to study Urdu language along with Arabic and Mantiq wa Falsafa (Logic and Philosophy) as a subject during the First Professional B.U.M.S session.
- vii. The Pre-Tib examination shall be for one-year duration.

**Note**: Candidates possessing qualification of the University/Board or an institution outside

the State should enclose a certificate of equivalence from Board of Intermediate Education of Telangana to the effect that the qualification possessed is equivalent to or higher than Intermediate examination with Biology, Physics, Chemistry and English conducted by the Board of Intermediate Education of Telangana.

- **E. AGE**: The Candidate should have completed 17 years of age as on 31-12-2024. The candidates who do not complete 17 years as on 31-12-2024 are not eligible for admission.
- Further, there is no upper age limit for admission to ASU&H-UG courses. Age shall be calculated on the basis of date of birth as mentioned in the Secondary School Certificate. Relaxation of age eligibility criteria of a candidate will not be permitted for under aged candidates.
- **G.** Candidates who claim for admission under Persons with Disabilities (PWD) category shall mention in the online application as applying under PWD category and have to appear for evaluation of their disability status before a Medical Board to be constituted for the purpose by KNR University of Health Sciences as per the schedule to be notified by the University for eligibility under PWD status.
- H. The candidates are advised to download and read the Prospectus/Regulations available in the KNR UHS website <a href="https://www.knruhs.telangana.gov.in/">https://www.knruhs.telangana.gov.in/</a> before filling the online application form for admission into BAMS, BHMS, BUMS & BNYS Courses for the academic year 2024-25.
- I. The NEET UG-2024 qualified and eligible candidates as per the concerned regulations who desire to take admission into AYUSH UG Courses in Government and Private AYUSH Colleges shall apply online and upload all original certificates for determining the Merit position for Telangana State Competent Authority quota seats. The online application can be filled through any computer with internet connection.

### (NOTE: PREFERBLY DESKTOP OR LAPTOP)

II. Registration and Verification Fee for BAMS, BHMS, BUMS & BNYS Courses:-

The Registration and verification fee is **Rs.2,500/-**(Bank transaction charges extra) for OC & BC category candidates and for SC/ST category candidates is **Rs.2,000/-** (Bank transaction charges extra). Fee shall be paid online through Debit card / Credit card or Net Banking.\*\*

\*\* Registration and verification fee once paid will not be refunded or adjusted to a further date.

## III. Procedure of filling online application and online payment for BAMS, BHMS, BUMS & BNYS Courses

- i. Read the Notification, Prospectus/Regulations carefully.
- ii. The registration fee can be paid through Debit card / Credit card or Net Banking.
- iii. The registration fee paid by the applicants is not refundable under any circumstances.
- iv. Visit website through Computer with Internet connection to fill the application form. Fill in all the details in the online application form and upload all the documents which are mandatory
- v. Registration number sent to the registered mobile after entering the basic data should be noted for further use. The Registration number should be kept confidential and not to be disclosed to others.

- h. Latest Permanent Caste Certificate (Integrated Community Certificate) claiming reservation under BC/SC/ST Categories issued by Competent Authority of Govt. of Telangana
- i. Aadhar Card
- **j.** Minority certificates issued by the concerned Department.
- **k.** Candidates who have not studied in any educational institutions have to submit 4 years (years of period to be specified) residence certificate of the candidate for period of study issued by MRO / Tahsildar of Govt. of Telangana for candidates appeared privately (for open school candidates).
- 1. The candidates claiming fee exemption shall produce the latest Income

- certificate of the Parent issued by MRO / Tahsildar of Govt. of Telangana.
- **m.** Undertaking in the form of Affidavit by the parent and candidate stating that the caste and area mentioned in the certificates are genuine and they will be held responsible for any further consequences as per law if any discrepancy noticed. (See Annexure-III).
- **n.** Candidates claiming eligibility of reservation under Special categories CAP should furnish the required certificate in support of their claim.
- e. EWS Certificate issued after April, 2024 and valid for the year 2024-25 for claiming reservation under EWS Categories issued by Competent Authority (Tahsildar) of State of Telangana (If applicable).
- p. NCC certificate for award of Grace marks as per G.O.Ms.No. 166, HM & FW (E2) Dept, dated. 23.09.2023.

### **IMPORTANT INFORMATION FOR CANDIDATES:**

- 1. Online application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area, incomplete applications will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2024 rank.
- 2. The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by candidate in the online application are accepted as true and correct.
- 3. Candidates may please note that the University will take up the verification of original certificates with regard to eligibility conditions i.e., NEET UG-2024 Rank, educational qualifications, local/non local area status, category status as per uploaded relevant certificates by the concerned department officials. If the information furnished by the candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deemed fit will be taken.
- 4. Candidates eligibility for admission into UG ASU&H courses for the academic year 2024-25 will be examined by the University only after scrutiny of application along with all uploaded copies of required certificates and provisional final merit list will be notified.

- 5. Registration along with uploading of scanned original certificates will be done only once irrespective of the number of counsellings. No separate notification will be issued for verification of original certificates. **Therefore, the candidates should register and upload all the mandatory certificates without fail.** 
  - 6. This notification is for online registration for determining the State Merit position in respective categories using NEET-UG-2024 rank only for eligible candidates. The schedule for exercising web options for admission to UG AYUSH courses will be notified separately on university website. Candidates are advised to check the University website <a href="https://www.knruhs.telangana.gov.in/">https://www.knruhs.telangana.gov.in/</a> for notifications, counseling schedules, seat matrix and other details from time to time.
- 7. An in-eligible candidate obtaining merit position does not make the candidate eligible for admission. Admission will be considered only for candidates, who have secured marks above cutoff score in NEET UG 2024 exam and based on the state merit order as the case may be.
- 8. Scrutiny of uploaded original certificates shall be conducted by the university and concerned department officials. After scrutiny of application and certificates provisional final merit list will be released. Candidates are advised to refer to KNRUHS website for further details regarding schedule for exercising web options. No individual communication will be sent.
- 9. Admissions will be in accordance with the Orders issued from time to time by Government of Telangana, Government of India, NCISM /NCH, relevant Hon'ble Supreme court and High Court orders. University regulations with regard to Admission into AYUSH Courses shall also apply.
- 10. After allotment candidate should download the allotment order, submit the printout of the filled-in online application form, allotment order, Bonds and original certificates along with (1) set of self attested copies to the Principal of allotted college, and pay the college fee and tuition fee at the time of joining. The Admission Committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.

All the eligible candidates whose names are notified in the provisional final merit list can exercise web options for admission into BAMS, BHMS, BUMS and BNYS courses from **6.00 AM on 09-11-2024 to 3.00 P.M on 10-11-2024** through website <a href="https://tsbahnu.tsche.in">https://tsbahnu.tsche.in</a> subject to following conditions:

- 1. Candidates who are admitted into MBBS & BDS courses under KNRUHS and in MCC counselling are also not eligible to exercise web options.
- Candidates who are admitted into AYUSH courses under AIQ and are notified as ineligible for state counseling by AACCC are also not eligible to exercise web options.
- 3. Candidates who were allotted UG AYUSH seats in the previous phases of counseling and who did not join the course/discontinued the course after joining are not eligible to exercise web-options.

Do not use Tabs or Mobiles to exercise web-options.
- 2) Candidates are advised to go through the Prospectus and the Government Orders on rules available on KNRUHS website before exercising web-options.
- 3) Candidates are informed that they have to exercise options to the course and colleges in which they are interested to join.
- 4) Candidates are advised to exercise web options for vacant seats in all AYUSH courses/colleges in which they are interested to join irrespective of available vacant seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in previous phases of counseling to other seats as per their web options in the Mop Up phase of counseling.
