**NOTIFICATION FOR ON-LINE APPLICATIONS FOR ADMISSION INTO MD HOMOEOPATHY  
COURSES UNDER MANAGEMENT QUOTA FOR 2024-25**

Applications on-line are invited from candidates who have qualified in AIAPGET-2024 (Homeo), who fulfilled the eligibility for admission into MD Homeo Courses under Management Quota by securing cut-off score and above for 2024-25 in affiliated Homeo Medical Colleges.

Candidates can apply on-line through web-site <https://tsmdayushmq.tsche.in> from **10.00 A.M. on 05.11.2024 to 10.11.2024 up to 06.00 PM.**

University shall issue notification for schedule of exercising one time web options by the candidates on the website after notifying the provisional final merit list.

On-line application can be filled through any computer with internet connection.

**I. ELIGIBILITY CRITERIA :**

- a. As per the guidelines issued by Ministry of AYUSH and National Commission for Homoeopathy, the following are the eligibility criteria for admission into Post Graduate Courses.
- b. Candidates who have appeared for AIAPGET 2024 and should have secured the following minimum eligibility percentile or above.
  - i) 50% for General Category (Open) candidates.
  - ii) 45% for General Category (Persons with Disabilities (PWD))
  - iii) 40% for SC, ST and other Backward class including Persons with Disabilities

\*Lower percentage / percentile of marks for SC/ST/BC/OBC /PWD is only for eligibility purpose and will not be applicable for reservations as there are no reservations under Management Quota

- c. Those who have passed the BHMS Degree Examination after undergoing a course of study in Homoeopathy of not less than 5 ½ years duration including the period of compulsory internship;

or

Those who passed equivalent Degree Examination included in the 2nd schedule of Homoeopathy Central Council Act 1973.

- d. The candidates should have completed internship by 31-07-2024
- e. Candidates who are already admitted and studying M.D. (Homeo) course shall not be permitted for counseling, until they discontinue the course before submitting the application form and such candidate shall submit the discontinuation certificate issued by the Head of the Institution along with the application.
- f. Candidates who are already holding a Post Graduate Degree in Homoeopathy in a subject shall not be eligible for admission into another P.G. Homeo Course.

## **II. MERIT LIST:**

Merit Position of the candidates who have applied on-line shall be determined based on AIAPGET-2024 (Homeo) rank and percentile as per their eligibility. The provisional final merit list of eligible candidates will be notified on KNRUHS website after verification of uploaded certificates.

**III. Registration and Processing fee :** Rs. 6,000=00 ( Bank Charges extra)

## **IV. Verification Fee for Equivalency:**

The candidates who have acquired their Under Graduate Degree outside the State of Telangana or abroad and got their certificates registered with Council and applying for admission under this University, shall pay a verification fee of Rs.5,000/- for degree certificates acquired abroad and Rs.3,000/- for the degrees acquired outside the State.

## **V. Instructions to Candidates**

Candidates are advised to download the Prospectus displayed on KNRUHS web-site: <http://knruhs.telangana.gov.in> and read carefully for eligibility criteria and other details before filling the application form.

## **Procedure of filling online application and Procedure for online payment:**

### **1. Keep all the following required documents ready.**

- (a) AIAPGET-2024 ( Homoeo ) Hall Ticket.
- (b) AIAPGET-2024 ( Homoeo ) Rank Card.
- (c) Date of Birth Certificate.
- (d) Study Certificate – B.H.M.S.( 1st year to final year )
- (e) Internship completion certificate. .
- (f) All marks memos from 1st B.H.M.S. to final B.H.M.S.
- (g) Category Certificate if applicable for eligibility
- (h) Council Registration Certificate.
- (i) Credit card / Debit card.
- (j) Aadhar Card.
- (k) **For NRI Quota:** Candidate has to click yes or no for consideration under NRI category. Candidate has to produce the following details at the time of admission.
  - i) NRI Sponsorship certificate (DECLARATION Form)
  - ii) NRI status certificate of the financial supporter issued by embassy of respective country under their seal.
  - iii) Copy of NRI Bank account pass book of the financial supporter.
  - iv) Copy of Pass port of NRI financial supporter

### **(l) Institutional Quota :**

Sponsorship Certificate from respective Homeo Medical College for Institutional Quota (MQ3)

- 2. The Registration and Processing fee can be paid through Debit card / Credit card or Net Banking
- 3. The Registration and Processing fee paid by the applicants is not refundable under any circumstances.

4. Applications on-line are to determine the provisional merit position. Provisional final merit list will be notified after verification of uploaded certificates at the time of certificate verification.
5. Print-out of application form should be submitted at the time of verification of Original Certificates and counseling along with 1-set of required copies at the time of admission at allotted college. Incomplete applications and applications without enclosures will not be considered.
6. Admissions are done in accordance with the orders issued by Government of Telangana in G.O.Ms.No.72, HM&FW (E2) Department, Dated:29-06-2023 subsequent amendments, University Regulations and Regulations of National Commission for Homoeopathy.
7. Candidates admission is strictly provisional. The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the on-line application are accepted as true and correct. The candidate has to note that the University will take up the verification of uploaded original certificates with regard to eligibility conditions. i.e. educational qualification, validity of registration with State Council and internship completion. Final verification shall be conducted by the Admission Committee of the college at the time admission. If the information furnished by the candidate in the application is incorrect, the admission is liable to be cancelled and further action as deems fit will be initiated by the University.

In continuation to this office notifications dated 04.11.2024, and in accordance with the NCISM Letter dated 11/11/2024, KNRUHS hereby notifies fresh online registration **for Management Quota admissions from AIAPGET- 2024** qualified candidates as per the revised cut-off score. Persons with Disability, PWD (OC)	30 <sup>th</sup> Percentile

**Note: Cutoff score of OC PH / BC / SC / ST is only for purpose of eligibility for admission. There is no reservation for Management Quota.**

In continuation to this office notifications 04-11-2024, 15-11-2024 and 20-11-2024, Kaloji Narayana Rao University of Health Sciences hereby notifies the conduct of first phase of counseling and exercising web-options for MD Homoeo courses under Management Quota in affiliated Private Homoeo Colleges.

Candidates who have registered online and whose names are notified in the consolidated provisional final merit list for Management Quota on KNRUHS website on 20-11-2024 are eligible to exercise web-options online from computer with internet connection.

All the eligible candidates can exercise web options for MQ1 and MQ2 categories as per eligibility and priority for college /course from **09.00 A.M. on 21-11-2024 to 3.00 P.M. on 22-11-2024** through web-site <https://tsmdayushmq.tsche.in>

**The Management of the colleges shall send the nomination letter for admission into Management Quota sub category 3 quota (MQ3) seats from eligible AIAPGET qualified candidates from the Management Quota merit list notified on website by University.**

**IMPORTANT NOTE:**

1. Candidates are hereby informed that web options can be exercised for MD Homoeo courses in all colleges. The web options exercised by candidates with regard to order of preference for courses/ colleges is final and the same options will be considered for allotments.
2. Candidates selected under Management Quota in the counseling conducted by KNRUHS for PG Homoeo courses at Private Homoeopathic Colleges are permitted to leave /surrender the seat till the last date of free exit to be notified by KNRUHS on website without penalty. If the candidate cancels the admission/ discontinues the course after the last date for free exit, candidate have to pay a penalty of Rs. 1,00,000/- in addition as per State Government order and they will not be eligible for MD Homoeo admissions under KNRUHS for 3 years.
3. Undertaking in the form of affidavit shall be submitted at the time of admission by the candidates stating that the submitted certificates are genuine and they will be held responsible for any further consequences as per law if any discrepancy noticed.
4. **UNIVERSITY FEE:** Allotted Candidates have to pay the following University fee through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter.

MQ 1 Management Quota sub category 1: Rs.25,000/-

MQ2 (NRI) & MQ3 (Institutional Quota) : Rs.40,000/-

The University fee once paid shall not be refunded under any circumstances. Tuition Fee to be paid as notified by Government of Telangana.



### **Important Instructions to Candidates:-**

1. Admissions into Management Quota of MD Homoeo courses are conducted in accordance with Government Orders issued in G.O.Ms.No.72, HM&FW (E2) Department dated:29-06-2022, University Regulations and Regulations of National Commission for Homoeopathy.
2. Candidate can exercise web options for MD Homoeo Courses as per their priority for the course and college. There is no limit to the number of web-options.
3. Candidates are informed that they have to exercise web options to the course and colleges in which they are interested to join. If they are not interested to join in course/college, they should not exercise options for the same. If a candidate is allotted a seat in MD Homoeo course as per their web options and does not join the course, the candidate will not be permitted for exercising web-options for subsequent phases of allotment.
4. Candidates have to exercise web-options for MQ1 category and for MQ2 (NRI) in order of priority for college and MQ1 or MQ2 category. Allotments will be made according to the order of preference in the web options exercised by the candidate
5. One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read instructions to the candidates before exercising web options).
6. Candidates are instructed to take a print out of saved options.
7. Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are directed to login to check their allotment status on Website <https://tsmdayushmq.tsche.in> without fail. Candidates are also informed to check the KNRUHS website from time to time for subsequent phase notification.
8. Allotted candidates shall download the allotment letter by paying the University Fee through payment gateway, check the allotment details and report to the Principal of allotted college before the last date mentioned in

the allotment letter.

9. Candidates shall submit the printout of the filled-in online application form, allotment order, Bonds and original certificates along with (1) set of self-attested copies to the Principal of allotted college. Candidate has to pay the college fee and tuition fee at the time of joining to complete the process of admission.
10. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and the candidate will not be eligible for subsequent phase of counselling.
11. Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college. The Admission Committee of the college is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
12. Original certificates will not be returned to candidate, unless the candidate discontinues the course.
